ORDINANCE NO. 10-694-05

AN ORDINANCE AMENDING THE SOUDERTON BOROUGH MUNICIPAL WASTE COLLECTION AND RECYCLING ORDINANCE NO. 07-667-03, ADOPTED APRIL 2, 2007, BY ADDING A PROVISION REQUIRING EVERY PERSON OR ENTITY TO HAVE MUNICIPAL WASTE AND RECYCLABLE MATERIALS COLLECTED BY A MUNICIPAL WASTE COLLECTOR LEGALLY OPERATING WITHIN THE BOROUGH, AND TO REQUIRE THE PLACEMENT OF RECYCLING CONTAINERS AT COMMUNITY EVENTS; REPEALING INCONSISTENT ORDINANCES.

The Borough Council of the Borough of Souderton hereby ENACTS and ORDAINS, as follows:

<u>SECTION 1. AMENDMENT.</u> Article I, Section 4 of the Souderton Borough Municipal Waste Collection and Recycling Ordinance No. 07-667-03 is hereby amended to add the following new Subsection A:

A. Each person or entity, unless exempted under Section 3(H) of this Ordinance who or which generates municipal waste and/or designated recyclable materials shall have such waste and recyclable materials collected by a municipal waste collector that is legally operating within the Borough of Souderton, and such collection shall be no less frequent than one (1) time per week. The existing Subsections "A" through "F" of Section 4 shall be re-designated Subsections "B" through "G".

<u>SECTION 2</u>. <u>AMENDMENT</u>. Article I, Section 5 of the Souderton Borough Municipal Waste Collection and Recycling Ordinance No. 07-667-03 is hereby amended to add the following new Subsection "D":

D. Community Events. Recycling containers shall be provided at all community events attended by 200 or more people. The disposal of recyclable materials collected at such events shall be in accordance with the provisions of this Ordinance.

<u>SECTION 3.</u> <u>SEVERABILITY</u>. The provisions of this Ordinance are severable. If any provision hereof shall be held invalid, illegal, or unconstitutional by any court of competent jurisdiction, such decision shall not affect or impair the remaining sections or provisions of this Ordinance.

<u>SECTION 4.</u> <u>EFFECTIVE DATE.</u> This Ordinance shall take effect immediately.

<u>SECTION 4.</u> <u>REPEALER.</u> All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
